The Dean of the Faculty of Business Management of the University of Economics in Bratislava announces pursuant to § 56 (3) and § 57 (5) of Act No. 131/2002 Coll. on Higher Education and on Amendments and Additions to Certain Acts, as amended

**opening of the admission procedure for the 3rd degree of studies
in the academic year 2023/2024**

**for 3-year full-time and 4-year part-time studies
in accredited study programme Economics and Business Management
in the field of study Economics and Management.**

E-application deadline: 9th April to 9th June 2023.

Candidates for the study programme of the 3rd degree at the FPM EU in Bratislava submit an electronic application form. The fee (according to paragraph 7 of Article 92 of the Higher Education Act) for the admission procedure for the 3rd degree of study is **32,- €** for the study programme economics and Business Management (in Slovak language).

Candidates for studies at the 3rd level of studies (doctoral studies) are obliged to send electronically to the address peter.markovic@euba.sk:

- Motivation letter in Slovak language (for study programme in Slovak language) or in English language (for study programme in English language).
- Framework project on the topic of the dissertation in Slovak and at the same time in English (for the study programme in Slovak language), or only in English (for the study programme in English language).

The framework project shall be submitted in approximately 10-15 A4 pages with an equivalent number of characters, including spaces, explanatory notes and footnotes in the range of 18 000-24 000 characters. The content of the project shall include:

- a justification of the motives for the candidate's choice of dissertation topic,
 - definition of the objectives and content of the dissertation, description of the methods expected to be applied in the elaboration of the dissertation topic,
 - a description of the current state of knowledge of the dissertation topic, based on a literature search.
- List of professional and scientific papers published to date, if any.

The above-mentioned documents must be submitted by **12nd June 2023** at the latest.

The entrance examination will be held on **23rd June 2023** at 9.00 a.m. (Friday). More detailed information will be sent to you by email after the assessment of the completeness of your application.

Note: Applicants admitted to the external form of study in the study programme (in the Slovak language) are obliged to pay a tuition fee of 1 000 € for each year of study.
